

I, Doug Lagore, have been appointed Official Administrator of the City of Chestermere (the "City") by the Minister of Municipal Affairs pursuant to Ministerial Order MSD082/22. My appointment was extended to March 31, 2023 by Ministerial Order MSD008/23 and further extended to December 31, 2023 by Ministerial Order MSD022/23. Below are my reasons in respect of the following resolutions:

- 230831-05

#### Resolutions 230831-05 and 230831-06

I have allowed Resolution 230831-005 which directs Administration to provide public notice of the intent to sell a parcel for below market value. I am still unclear why the City has not considered offering this parcel to the two other adjacent landowners, however, the City has met the minimum requirements in the Municipal Government Act and I note that the City had identified that their legal counsel raised concerns about an irregular lotting pattern if one of the other two adjacent landowners purchased the lands. As such, I allow Resolution 230831-05.

I do not allow Resolution 230831-06. I find this is in effect a reduction in the purchase price directed by City Council and the value of this additional benefit should be quantified for public transparency. There is no basis in the Agenda Package for why the City would pay for the appraisal, advertising, survey consolidation and legal

fees for a third party when selling City land. Further, there is no identification of what these anticipated costs are. As such, I disallow this Resolution.

#### Resolution 230831-08 and 230831-10

Following my disallowance of Resolution 230725-26, the City brought the matter onto the public agenda for the August 31, 2023 Special Meeting.

Council has not addressed a number of the concerns I raised in my report on the July 25, 2023 Minutes. I reiterate those concerns. I further have significant concerns about the documentation being discussed at the City Council meeting which was not provided to me. For example, the "presentation" by the landowner was reference by Council members. I have never received a presentation from the landowner. I understand he attended the Council meeting on June 27<sup>th</sup>.

I have received no written request from the landowner identifying why they are seeking a refund of property taxes paid. There is very minimal documentation in respect of this request for a refund of a significant sum of money.

I am also unclear that if the basis for the refund of taxes is due to the limitations being placed on this property by either Alberta Transportation or the City, why those have not been clearly set out to Council. Councillors have stated that the land is sterilized by Alberta Transportation, I am unclear if this is an accurate reflection of Alberta Transportations position and I will be reaching out to Alberta Transportation for clarification. On the basis of the information before Council that has been provided to me, I am not convinced that the property has been sterilized such that the property owner cannot use it to justify a refund of taxes. A property owner's failure to develop a property in a particular time period does not mean it is sterilized. Nor is a property sterilized if the use that it can be put to is limited. If a property does in fact have specific limitations on its use, this should be incorporated into the assessment based on the market value of the property. If an assessor fails to do so, the property owner may bring a complaint to the assessment review board.

I further expressed concern that as the City appears to be taking the position that the property was over-assessed, it is surprising it would not consult with its assessor. No comment from the City Assessor was provided to Council. It may be that the City Assessor did consider the restrictions on use of the property in preparing the annual assessments. It may not be. However, City Council and I do not know. The member of Administration who presented to City Council identified that they were not an assessor. City Administration and Council Members have continued to compare the municipal taxes paid by this parcel with neighbouring properties, some of which are assessed on the basis of agricultural use value rather than market value. a blatant error. It is unreasonable for Council to refund taxes paid due to a property taxed based on market value paying more than a property taxed based on agricultural use value.

Administration also appears to use 2009 as the reference point as it is the annexation year. The property was within land annexed to the then Town of Chestermere effective January 1, 2009. As part of that annexation Order in Council, the property has been taxed at the lower of the applicable mill rate of the Municipal District of Rocky View No. 44 of the City of Chestermere until a triggering event or December 31, 2023. There is no information that I have been provided that the tax protection under the annexation order was not properly implemented for this property. If it had, I would have considered this to be a reasonable exercise of Council's discretion.

Section 347 provides an important tool for a municipal council to refund taxes where it considers it equitable to do so. The equity of refunding taxes in this matter is not clear to me as has been set out in my previous reports. City Council can exercise discretion to refund taxes where it considered it equitable to do so, however I find that there is no basis on which City Council could have reasonably concluded that it was equitable to refund taxes in the amount of \$110,528.71 and that such a resolution is irregular, improper and improvident.

I further have serious concerns about the tax refund for this property due to the subsequent conduct of the City in respect of this property. I have been advised that the City staff have entered onto this property and engaged in a cleanup of some kind and have been provided photographs in support.

I have asked the City Administration who authorized this work. The City has not responded. I find the City's actions in respect of this property to be irregular, improper and improvident. It is of substantial concern to me that the City is refunding taxes to a property owner and then entering onto the property for an unclear basis and undertaking work at what appears to be the municipal taxpayers expense.

I ask that the Minister appoint an investigator into the City's dealing with this property owner in respect of:

- Council and individual Council members actions in respect of this property and the appropriateness of such actions:
- What communications individual Council members have had with this property owner and their discussions regarding tax refunds, in particular outside of Council meetings and the appropriateness of such actions:
- Individual Council members role in administrative meetings regarding this property and the appropriateness of such actions; and
