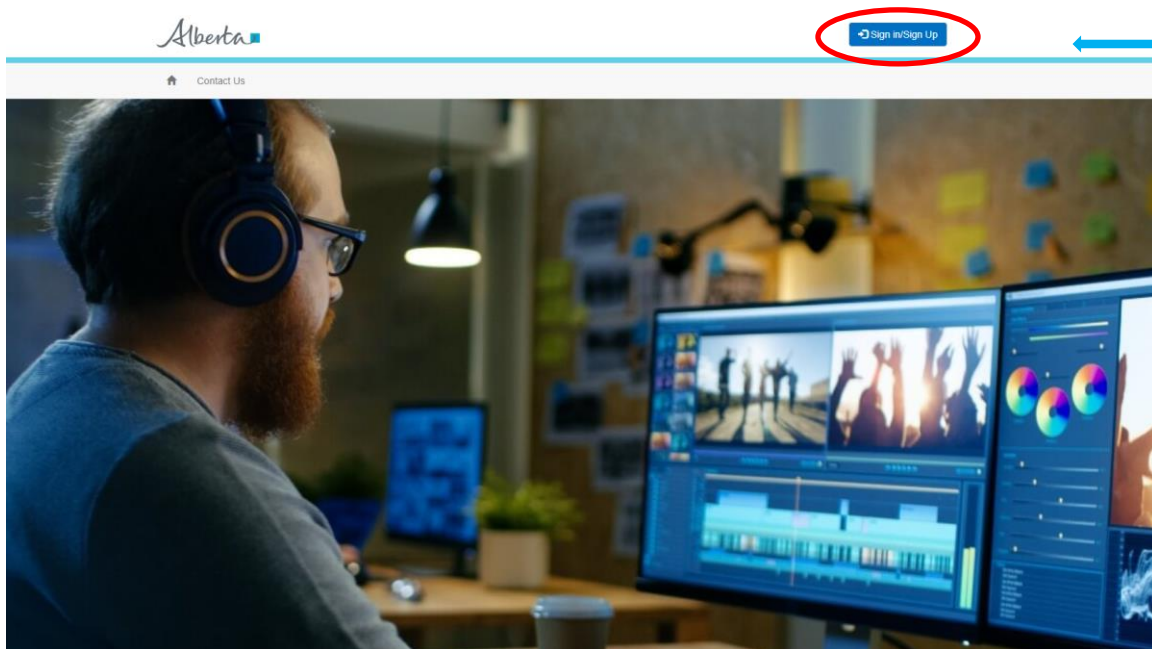
## Access the portal

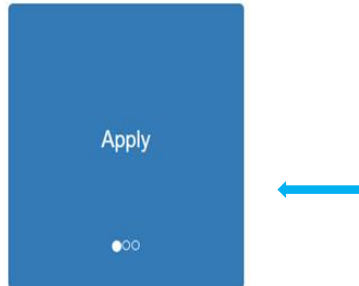
